Just as this issue of the Newsletter was being finalised, disappointing news came in from the Heritage Lottery Fund to inform us that we had not been successful in our bid for funding from the HLF towards the cost of our project to reinstate the Time Ball mechanism at Margate Clock Tower. We were hopeful that the HLF would wish to give financial support to our worthy project but the HLF had received so many requests from organisations that it was inevitable that some of those organisations would be unlucky. It was our bad luck that our Society fell into that category.

However, we are already well on our way towards meeting our fund-raising target as will be seen from Lynda Smith's positive report on pages 6 and 7 of this Newsletter. Indeed, we have passed the half-way mark and have already attracted the support of a number of local businesses. In the last Newsletter, we reported on the generosity of Gore Brothers (Funeral Directors) in meeting the cost of printing our Clock Tower book and in the current Newsletter, we report on the generosity of Boys & Maughan (Solicitors). J D Wetherspoon (The Mechanical Elephant Public House), Standfast (Security Specialists & Locksmiths) and Mansfield Property Maintenance. Each of these businesses has wanted to contribute to our project in support of the town. It is most gratifying that, in these economically difficult times, such generous support is being given to our project. Let us hope that other businesses and, indeed, individuals will want to give their support to our very worthy project. Please do give the Society your support. Donations can now be made through our website by PayPal.

We will continue to seek ways of raising funds to meet our target. Indeed, the Society has arranged for Christmas cards to be made available with the proceeds going to the Time Ball appeal. Details of our attractive Christmas card are shown on page 3 of the Newsletter. Another means of raising funds is the sale of Clock Tower mugs. In addition to these mugs being on sale at our meetings held at the Walpole Bay Hotel, these mugs can also be purchased from the Cupcake Cafe in the Market Place. The Cupcake Cafe is making no charge for the selling of our mugs so all the sale proceeds (at £8.50 each) go direct to our appeal. This is yet another example of local businesses giving their support to our project by selling our mugs at no cost.

The Margate Clock Tower Time Ball project's aims were to give more awareness of Margate's Heritage to our younger community. It would also show National Heritage Lottery that the project was all inclusive to help our application for funding.

It was established that the best time to hold the competition would be during the run-up to Civic Day. Three categories were decided upon: Margate Clock Tower, the Tudor House and Turner Contemporary. Three artists accepted Lynda's request to judge the pictures: Ralph Handscomb, (the Society's President), Pat Wilson-Smith and Sally Childs, local artist and also member of MCS. From a meeting between Pat Wilson-Smith, Susie Godfrey and Lynda Smith at the School in May it was established that Key Stage 1 (KS1), the 5-7 year olds and Key Stage 2 (KS2), the 7-11year old children, would be separate prize winners.

Pat Wilson-Smith, who on previous years has kindly allowed the Society to use her facilities on the Stone Pier for Civic Day exhibitions, accepted a request to produce the front of a flier which was to be distributed giving information about Civic Day celebrations. It was established that Margate Clock Tower, Droit House (where Margate Civic Society was to hold their exhibition on Town Pride awards), Margate Museum and the Tudor House were to be featured on the flier and shown as a map with the four (No entries were submitted for either Turner venues shown clearly and on what street. A request to Adam Wilton, of English in Margate, to sponsor the prizes was gratefully agreed and the Society would like to give special thanks to Adam Wilton for this kind gesture. Ralph Handscomb and Lynda Smith chose the prizes from Lovely's which cost approximately £100. When the time came to collect the art work on Friday 14th June, the need for far more display boards became very apparent. Offers of help came from various quarters and finally there were enough space, display boards and people to put everything together in time.

The judges were so impressed by the calibre of the art that it was decided that commendations were also to be given. When the winners had been chosen the school was notified to inform the children and parents. At four o'clock on Monday afternoon Harry Scobie, Vice-Chairman of the Margate Civic Society presented the prizes. A photographer was on hand from the Isle of Thanet Gazette to take a photo of the children who had won and this took place in the garden of the Tudor House.

The fliers were purchased from part of an event's grant from TDC with the cost being shared with Margate Museum and the Tudor House. Approximately half of the fliers were given to the school for the pupils and their parents with the rest distributed to the public and local businesses.







THE TIME BALL RESTORATION PROJECT - UPDATE

The Dedication ceremony for the Margate Clock Tower Time Ball is now just nine months away. The committee is very grateful to Cllr John Edwards, Town Mayor of Margate, who has agreed that his office will organise this

Invitations to dignitaries and road closure applications, along with procession and route details are all to be dealt with from the Mayor's office.

The Society will not know whether an invitation to HRH The Prince of Wales to attend the Time Ball Dedication ceremony is to be accepted until after November when his diary is opened for 2014. However, a suitable venue to hold a reception has been considered and with this in mind the newly-opened boutique Sands Hotel in Margate has been approached. This splendidly restored building is a beautiful asset to our town.


None of the donations collected for the Margate Clock Tower Time Ball restoration project are to be used for the planned reception; instead a Thanet District Council event funding application will be submitted to help cover this along with a small charge for the invited guests.

We are in negotiation with Pam Hardiman of the Theatre Royal Margate and Clifford Lister MD of the Thanet Festival Choir to explore the possibility of a belated concert which would take place at the Theatre Royal on 24th May 2014 in celebration of HRH Queen Elizabeth II's Diamond Jubilee.

A local firm of solicitors, Boys & Maughan, have generously sponsored the production costs of the last 50 certificated Margate Clock Tower commemoration mugs and I was very pleased to receive a cheque for £250 from their senior partner, Mr Peter Rodd, which more than covered the cost. The committee are also very grateful to Boys & Maughan who have offered the Society free legal advice, which may come in very useful when we enter into a partnership agreement with Thanet District Council over the restoration of the Margate Clock Tower Time Ball. Mr Rodd has invited me to talk at the Margate 41 Club (ex-Round Tablers) meeting in January about the restoration project and has offered payment, which I shall be happy to donate to the project. I am pleased that the *Isle of Thanet* Gazette covered the presentation with a splendid article by Mr Ian Priston, Manager of Boys & Maughan.

A few weeks ago, I sent an open invitation to those members who receive their newsletters electronically inviting them, (for a small donation to the Time Ball project), to our house in Addington Square for tea/coffee and biscuits. My husband, Harry, and I were very pleased to receive those who did come; it was all very sociable and very nice to meet some members that I had not met before.

Margate Civic Society will have Christmas cards for sale as a fund raiser for the Time Ball project. The card has been designed and produced by Mike Wilton, our Treasurer, based on an image kindly supplied by our Patron, Arnold Schwartzman OBE RDI. It is hoped that the Christmas card will prove to be very popular, not only to our members but also for anyone who holds Margate dear. Details of the their grant money to go towards the project.



The developer of the Arcadian Hotel in Margate, Mr Geoffrey Berger, has kindly helped to sponsor the production costs. Mr Berger is also a member of Margate Civic Society.

On a very hot August evening, I walked down to Margate sea-front to find some cooler air. I witnessed a sunset as beautiful as could be seen anywhere in the world. I sat on the new steps and gradually the lights came on from the stone pier to the sea-front arcades. I looked to my left and saw Margate Clock Tower with not one light to illuminate any part of it; I could have wept to see this depressing sight.

To overcome this, we are giving consideration to funding solar panels fitted on top of the balustrade of the Clock Tower to enable it to be illuminated without cost. application for EDF energy green fund is to be submitted to pay for this. It is hoped that when scaffolding is erected for the Time Ball repair, it will serve to be used for both purposes.

We are pleased to announce that the Margate Clock Tower Time Ball project account now stands at £6,383.25, which is more than half way towards the amount needed to pay for the Time Ball restoration work to begin. The Kent County Councillors for Margate and Cliftonville, Will Scobie and Mo Elenor, have each agreed for £1,000 of Christmas card are shown elsewhere in this Newsletter. grants will be earmarked specifically for scaffolding providing an information 'lectern' to be placed in the vicinity of the Clock Tower detailing its history, restoration, etc.

It's a great cause that certainly merits widespread support and we will be doing all we can to encourage more people to get involved.

"Our main contribution is likely to be when we assist the current committee in its dealings with Thanet District Council when it reaches its fundraising target," added Peter. "We will also be helping out with various money raising initiatives."





Taking a closer look at Westgate's Town Hall Buildings

Westgate's Grade II listed Town Hall Buildings deserve close study. Sometimes described as being built in the Swiss Gothic style, the whole building has to be one of the most interesting and ornate in our area. It was built in 1909 and opened in 1910.

Do look up when you are passing the Town Hall Buildings and admire the ornate decorative leaded windows above the ground-floor windows. It can be seen from the above photograph that the pattern used in the entrance to the Carlton Cinemas is slightly different from that used along the frontage of the building. It can also be seen, in those photographs above taken using flash, that some of the glass is coloured. The flash photographs above also allow the fine quality of the woodwork to be fully appreciated.

The Wonders of Westgate Sussex Mansions, Sussex Gardens

Westgate-on-Sea's Three Coats of Arms

The Westgate-on-Sea coat of arms on the Town Hall Buildings



The above photograph shows the impressive town crest displayed at first-floor level on the south side of the Town Hall Buildings. The Latin motto reads: AD PORTAM OCCIDENTALEM CURRO which translates to: I RUN TO THE GATE OF THE WEST.

In 1909, A Westgate Arts & Crafts Exhibition was held and was reported on in the *The Isle of Thanet Gazette and East Kent Advertiser*, dated Saturday, 27th March 1909. According to that report: *Sir William Ingram offered a prize for the best design suitable for a coat of arms for Westgate and this was won by Mère Ste Pierre of the Ursuline Convent, and, it is understood, the design has been approved by the Parochial Council and Parish Council. The design includes a portrait of St Mildred, a deer, the Kentish horse and a galley [sic]. It has Dent-de-Lion Castle as a crest and bears a motto which, translated, means "Driven by the wind to Westgate and there it will remain".*

Puzzlingly, the Westgate coat of arms seen on the Town Hall Buildings is clearly different from the Mother Superior's design. So what happened to the Mother Superior's design? Nobody seems to know.


The silver cup, illustrated, bears a similar design of the crest shown on the Town Hall Buildings with same Latin motto. It was made by G. W. Saxby who were jewellers in Margate High Street for many years during the early part of the twentieth century. It is possible that the cup was a presentation cup awarded at a sporting event such as the annual five-mile run around Westgate inaugurated by Sir William Ingram. This cup was discovered recently at a local collectors' fair.

The third of Westgate's coat of arms is the one that is used today and can be seen on the 'Welcome to Westgate' sign on Canterbury Road and was much used on crested-china souvenirs of Westgate a hundred years ago.

Indeed, there was a huge market from around 1900 to the late-1920s for crested-china souvenirs. The accompanying photograph is of a pin-tray dating from around 1910. Other examples of crested-china bearing the same Westgate crest, can often be found at antique fairs, etc.

Why Sir William Ingram should have decided to feature a design of a coat of arms for Westgate on his Town Hall Buildings other than the one that won the prize for the best design remains a mystery.





Founded in 1968, the Margate Civic Society is a registered charity. It is a founder member of Civic Voice and is affiliated to both the Kent Federation of Amenity Societies and the Kent History Federation.

The Society also vets planning applications and makes known to Thanet District Council any objections to those applications which it considers necessary.

Evening meetings are held monthly between October and May at the Walpole Bay Hotel, Fifth Avenue, Cliftonville. The lectures, mostly illustrated with slides, are interesting and of local interest; they are also varied in their appeal. A few afternoon meetings are sometimes also held. A Newsletter is published four times a year.
