If you haven't yet visited the exhibition at Turner Contemporary JMW Turner: Adventures in Colour, do make every effort to do so for the exhibition has to be one of the best - if not the best - that has been mounted at Turner Contemporary since it opened in April 2011. The exhibition comprises over 100 of Turner's paintings, drawings and engravings and includes many watercolours of Margate. The exhibition is on until 8th January 2017 and, of course, entry is free. Turner Contemporary is open every day except Mondays but do check first if visiting over the Christmas period. The exhibition is worth visiting more than once in order to read all of the captions and to look closely at the paintings. The exhibition is proving very popular drawing large numbers of visitors from all parts of the country and is exactly what many local residents have been looking forward to since the gallery first opened more than five years ago. Congratulations go to Victoria Pomery and her team on putting such an important collection together for display at the gallery.

This edition of our Newsletter contains a report on the handing over to Westgate-on-Sea Town Council of two Westgate-related silver cups intended as part of the splitting of Margate Charter Trustees' assets following the creation of Westgate Parish Council on 1st April 2015. The handing-over-of-the-cups ceremony took place on 26th October 2016 but, within only a few days, it was discovered that the St Mildred's Cup might not have been owned by Margate Charter Trustees but by Margate Bowling Club. The cup had been held by the Charter Trustees and had been passed over to Westgate-on-Sea Town Council possibly in error. It is understood that arrangements are now in hand to return the St Mildred's Cup to the Charter Trustees if indeed it is confirmed that the cup does belong to Margate Bowling Club. The smaller of the two cups, the Westgate-on-Sea Challenge Trophy is believed to have been the property of the Charter Trustees but, as its origin is currently unknown, there is a possibility that this cup too was not owned by the Charter Trustees. It was the intention that the passing over of these two cups to Westgate-on-Sea Town Council would finally end the 'squabble' between the Town Council and Margate Charter Trustees over the splitting of the Charter Trustees' assets as at 31st March 2015. It has to be said that the issue of Westgate's share of the Charter Trustees' assets has consumed a large part of the new Town Council's time since May 2015 and it was hoped that the passing over of the two cups by the Charter Trustees would finally draw the matter to a close. It will be interesting to see what happens next.

The St Mildred's Cup - presented by the late Councillor F. A. A. Herbert who, for many years, managed 'Millies' and the Tudor Bar at the former St Mildred's Hotel which will be remembered fondly by some of our older members. This cup is EPNS (electro-plated nickel silver). The socle bears many names, the first being Mrs N. Maker and Mrs B Davies who were awarded the cup in 1983 and last being Mrs J. Benfield (Ramsgate) and Mrs B. Farnham (Ramsgate)who were awarded the cup in 2011. It is believed that the cup was presented each year to the winners of a ladies' doubles bowls match or tournament held in Margate. *Can anyone provide any* information regarding this cup?

This archive photo of The St Mildred's Cup shows it with its original socle. The photo above shows the additional larger socle that was subsequently added at its base when space for additional names on the original socle had ran out.

This solid silver cup bears a silver hallmark for 1936 yet the socle on which the cup stands bears only three names: Wendy Robinson in 1961 and - in 1963 - Priscilla Varrall and David Gardiner. Does anyone know what this cup was presented for in those years and whether it had been presented to anyone in earlier years?

Dr Dawn Crouch was invited to attend the ceremony in her capacity as the first Honorary Freeman of the town of Westgate-on-Sea and to give a talk on the origin of the two cups. In her address, Dawn suggested that perhaps the Town Council could organise some suitable competitive events for which the cups could be awarded each year. She felt that it would be good if the events were particularly aimed at the young people of the town.

Dawn also mentioned some of the other silver cups that had been awarded for events in Westgate. One of those was for the annual 5-mile race. Another cup was the Cornford Cup which had been presented by Alderman Frederick. J. Cornford - Councillor Joanna Cornford's father. Sadly, the whereabouts of those cups - and other cups (see archive photos below) - is not known. \Box JB

Margate Remembers its Fallen - Remembrance Sunday 2016

The year 2016 witnessed the centenary of two of the bloodiest battles of the Great War - the Battle of the Somme and of the Battle of Jutland. Appropriately, two of the wreaths laid at Margate War Memorial on Remembrance Sunday (13th November) were specifically in memory of those from Margate who fell in those two terrible battles.

The congregation for this year's Service of Remembrance at the war memorial was probably even larger than last year



and it certainly seems that the number grows each year. For this year's service, the sun came out and it was a beautiful November morning.

Although neither of the two local MPs attended this year, the Deputy Lord Lieutenant of Kent did so along with local dignitaries as can be seen in the accompanying photographs. Again, it was good to see so many of the local youth organisations present at the service and it was particularly good that, this year, the names of those who laid wreaths along with the organisation that they each represented was read out for the benefit of the congregation. Perhaps the service was a little late in starting but, for some reason, the Lord's Prayer, which was printed in the Order of Service, was omitted from the live service. **JB**

Margate's Roll of Honour 1914-18, etc

Many members of the Society will have noticed the many changes to the Isle of Thanet Gazette during the last few months. Some members may have noticed that the regular month-by-month contribution published since the beginning of the centenary of the Great War reporting on the servicemen from Margate who gave their lives in the Great War has been dropped. The discontinuance of these monthly contributions along with the cessation of articles from Dan Wellar and both Mike Pearce and Jane Wenham-Jones - together with the recent increase in its price to £1 have all resulted in a very different style of the Isle of Thanet Gazette. From the many comments that I have heard, the changes have not proved popular with many of its readers. Indeed, many have told me that they are thinking of not buying the Gazette in future when the Thanet Extra is available free of charge.

Many readers are sad that Kathy Bailes is no longer Editor of the Gazette (she has been replaced by a Brands Editor covering - I believe - all of the newspaper group's publications throughout Kent). It was Kathy who followed Rebecca Smith as Editor of the Gazette and it was Rebecca who asked me some four years ago if I would contribute to the Gazette throughout the centenary period of the Great War. Rebecca was particularly anxious that her newspaper should be involved in marking the centenary of the Great War and she called together a meeting of local historians to promote Thanet's involvement in the Great War. I was only too pleased to answer her call and I offered Rebecca a month-by-month series of articles which she accepted. Of course, the articles were all voluntary and no payment was made for them. Indeed, even had Rebecca offered me a nominal sum, I would have declined it. My contributions were published by the *Gazette* each month for two years. I submitted the August 2016 article for publication but heard nothing back from the Gazette. I had expected the article to be published on the first Friday of August and was disappointed to find that it had not been published. I then expected it to be published in the following week's Gazette, but again it was not there. After the third Friday in August, I contacted the Brands Editor only to be told that he would seek to publish it in a future issue. I have heard nothing back from the Brands Editor.

Surprising, in the issue of the *Isle of Thanet Gazette* dated 11th November 2016, there featured a full-page article headed 'Remembered: Wartime heroes from our county'. The article featured six service personnel including two from the Great War. One of the two 'heroes' from the Great War was Pte Thomas Highgate from Shoreham who was 'shot at dawn' for desertion. To describe him as being a 'hero' is questionable at best. There were a number of servicemen from Kent who were awarded the Victoria Cross during the Great War including Sgt Harry Wells from Herne and Cpl William Cotter from Folkestone. Surely, these are far more deserving to be described as 'heroes' than is Thomas Highgate. Of course, others might disagree with such a view. □

Memories of Setterfield's Dairy at Westgate

According to the late Bill Hambidge, in his book Westgateon-Sea 1909-1969 Memorized, No. 1 Cuthbert Road around 1900 was leased by a Mr & Mrs Osbourn who lived at Hundreds Farm and was a most successful dairy. Indeed, it was regarded as the best dairy business in Westgate. After Mr Osbourn died, the business was taken over by their daughter and her husband, Tom Setterfield, who both lived over the premises. Bill Hambidge refers to Tom Setterfield as having been a great character who had been generally referred to as 'The Mayor of Westgate'. During his lifetime, Tom Setterfield was, for several years, Chairman of Westgate Parish Council. The dairy business carried on after the end of the Second World War but later (possibly in the 1960s) the building became a laundrette which it still is today. The red-brick building was almost certainly built in the 1880s and features a Dutch gable high

above its front door. The architectural style of building is today known as Queen Anne Revival. It is believed that the MILK lettering on the chimney stack was cleaned a few years back as it is an important heritage feature of the building. It is thought likely that the architect of this building was Charles Nightingale Beazley, who was Westgate-on-Sea's original estate architect. He designed the original St Saviour's School which also features Dutch gables.

Local resident Syd Shoesmith, who lived in Linksfield Road before the Second World War, remembers seeing a herd of cows each morning walking up St Mildred's Road and over the railway bridge before turning sharp left into Setterfield's Dairy for milking. It must have been quite a sight for visitors to Westgate to witness such a rural scene in the centre of smart Westgate. The china model of a cow (see below) bearing the Westgate-on-Sea crest was almost certainly marketed for sale to such visitors to the seaside wanting to take home a souvenir of their visit to Westgate and seeing a herd of cows in the town each day. Models such as the cow were manufactured in the Stoke-on-Trent area and were popular from the early 1900s to the late 1920s. Most crested china souvenirs were of pots, urns and vases but the more unusual models, such as this cow, are today very collectable. \Box

Another super old aerial photograph of Margate: Circa 1930



Two recent issues of the Newsletter have each contained a super aerial photograph of Margate taken in the 1920s/30s. Chris Sandwell has now come up trumps with the above circa -1930 photo showing Margate College with its playing field in foreground. On the left-hand side of the photo can be seen Union Crescent and Cecil Square and in the bottom right-hand corner of the photo can be seen the old gasworks with its very tall chimney. Judging by the cleanliness of the building, the then recently-built block housing the former Woolworths store and Burtons mens' clothing store, amongst other shops, in the High Street can be seen clearly. The former White Hart Hotel can be seen in The Parade. There were a large number of trees in the centre of Margate in those days particularly around the former Margate College where the (relatively) new shopping centre (known as College Square) is now located. Dane Valley as seen from Drapers' Windmill - Circa 1900

This super photo of Dane Valley, which is believed to have been taken around 1900, was recently very kindly given to Margate Civic Society by Peter May, who lives in Birchington. He started working for the Westgate & Birchington Gas Co in 1944 when he was 14. The gas industry was nationalised in 1948. He worked in the gas industry until he retired in 1990. The photo above and the photo on the left are enlargements of areas of the panoramic photo above. The above photo shows the Dane Pumping Station and photo on the left shows the Pumper Mill. The Pumper Mill originally had sweeps and was used to pump water by wind power. The Pumper Mill was completed in 1875 and was demolished - it is believed - in the 1920s. Dane Pumping Station was built around 1880.

Station was built around 1880. It is thought that Dane Pumping Station became surplus to requirements when Wingham Pumping Station was opened in the early-1900s. Part of Dane Pumping Station (that part seen to the left off the tall chimney seen in the photo) was converted into a private dwelling which, coincidentally, recently came on to the market for sale. The photo below on the

right show the Pumper Mill from the opposite view with Little Drapers' Mill to the left and the still extant mill to the right.

More Ordnance Survey Benchmarks in Margate

In the last issue of the Newsletter, we featured a review of Steve Moore's new book Fading Benchmarks and published a number of photographs of some of the benchmarks found in the Addington Road area of Margate. These benchmarks were found after being inspired by the book to search for benchmarks. On a recent walk to Margate Railway Station, found three we more benchmarks all within a few



hundred yards of each other. The first of these three can be seen near the bottom of the wall of the former Lloyds Bank building on the south side of Canterbury Road, Westbrook not far from the junction with Westbrook Road). It is not easy to see nor to photograph as can be seen from the following three photos:



These two photos show the location of the benchmark



It has to be said that this benchmark has almost been obliterated by someone having painted the bottom of the building with black paint. The benchmark was noticed only because the sun was shining on it that day and cast a shadow which drew attention to the benchmark

The next benchmark found that day was one that is illustrated in Steve Moore's book but without any indication of its actual location other than it being at Margate. We were delighted to find its location as it is a 'flush bracket benchmark' which is a bronze plaque set into the masonry. We had previously found a similar 'flush bracket benchmark' set into the wall of Sandwich Guildhall so we knew exactly what they look like. According to Steve Moore in his book Fading Benchmarks, these 'flush bracket benchmarks first appeared in England and Wales between



1912 and 1921. Each such benchmark has a unique serial number embossed on the plate as can be seen in the above photos. The plate above can be found on the north-eastern corner of the newer building in front of the 1863 water-tower at Margate Railway Station. Do look for it when you are next in that vicinity.

The last of the three benchmarks found in the Westbrook area might be open to challenge for the arrow is now almost hidden as can be seen in the following photo:





This arrow inscribed in the brickwork does seem to be exactly the same as the arrow design that was used by Ordnance Survey in their benchmarks. It is low to the ground but perhaps, when the current Railway Station was built in 1923, the ground level was raised some inches. Who knows? The building is, of course, the 1863 Grade II listed Victorian watertower at Margate Railway Station

Good hunting! \Box

Memories of Margate's Piers and Jetties

This article was prompted by Alf (Legs) Beeching's interesting article in *The Margate Handbook* for November 2016. In his article, Alf described how the Margate Pier & Harbour Company decided to build what was then described as an 'artificial landing place' at the back of the stone pier. The 'artificial landing place' was deemed necessary 'to provide greater accommodation of the public in their embarkation and disembarkation at low water'.

Les's article encouraged me to take another look at the engraving reproduced below:



The caption to the above engraving, which was published by Rock & Co, reads:

Margate Pier & Jetty The splendid Pier of this delightful Watering Place was erected in 1812 at a cost of nearly £80,000, it is 856 feet long and 18 feet wide. 102,647 Persons landed on/or disembarked from it during the last season

When I had first read the caption, I thought that it was referring o the 'artificial landing place' (which later became known as Jarvis's Jetty) seen in the foreground of this image but, after having read Alf Beeching's article, I realised that the Pier referred to in the caption was the Stone Pier and not the 'artificial landing place' as the latter was not erected until the 1820s.

I contact Anthony Lee who kindly wrote:

"According to a report in the Kentish Gazette (18th November 1823), work on the low-level landing place (Jarvis's Jetty) started in 1823 and was completed by July 1824 (Kentish Gazette 13th July 1824). At Margate the 'Pier' referred to the Harbour (the 'Pier' was the built bit, and the harbour was the expanse of water contained by the Pier, and so the whole lot together was referred to as 'the Pier and Harbour'). 'Jetty' was just a word used for a timber construction along the shore line, intended to protect the shore against flooding – so, for example, the Parade was protected by a wooden jetty, later replaced by a stone jetty. So I guess that since 'Pier' was already used for the Harbour, when Jarvis's low level wooden landing place was built, it came to be known as 'the Jetty' – and when the original wooden 'Jetty' was replaced by the Victorian iron construction it retained the name 'Jetty' – meaning that Margate was unusual in that what Victorian visitors to Margate would walk along was called the 'Jetty' rather than being called the 'Pier' as at other seaside resorts. The original Pier at Margate was destroyed in the storm of 1808 and was replaced by a Stone Pier designed by John Rennie. The first stone of the new Pier was laid on 5th April 1810 (Kentish Gazette April 13 1810). I'm not sure when the new Pier was finally completed but Oulton in his Margate guide-book of 1820 says 'the new Pier is now nearly completed'.

So there we have it. The detailed caption of the engraving is referring to the Stone Pier which was erected in 1812 rather than to the 'artificial landing place ' (Jarvis's Jetty) which was not completed until 1824. It remains, however, a matter of conjecture as to which year the caption refers.

It is possible that an earlier version of the engraving (not showing Jarvis's Jetty) was published shortly after the Stone Pier was built in 1812 and that a later version of the engraving was published in 1824 (or shortly after) showing Jarvis's Jetty. As the engraving is not dated, we shall probably never know.

Anthony Lee also very kindly supplied the following image of a watercolour dated 12th July 1812:



The above painting shows the building of the new Stone Pier, with the old Pier on the left and the new Pier, projecting further out into the sea, on the right. This is a most interesting scene and demonstrates how much bigger the 1812 Pier was compared with the earlier Pier. The church in the background is believed to be either All Saints Church at Birchington or the Two Sisters at Reculver

My thanks to Anthony Lee for confirming my understanding of the history of both the Stone Pier and Jarvis's Jetty and for giving permission to publish the 1812 watercolour in this issue of the Newsletter. □

Arnold Schwartzman OBE - visit to South Korea in September 2016

Minefield artist

There is quite a considerable difference between painting a picture in the middle of a Korean minefield and covering a canvas in the peaceful surroundings of one's home, but Mr. Arnold Schwartzman has done both.



Arnold, the 21-year-old son of Mr. and Mrs. D. Schwartzman, of the Hotel Majestic, Lewis Crescent, Margate, has just returned home from a 14-month tour of duty in Korea. He intends to make com-mercial art his career.

During his two years' service in the Educational Corps of the Royal Sussex Regiment, Arnold visited 14 countries, but he thought Korea a "grim place," which, however, provided "good experience." He was a member of the only British force to be attached to the Americans.

Arnold found plenty of time to paint out East, and many of his murals may be seen in officers' messes and canteens. He also executed a number of posters for special occasions.

Overshadowing these efforts. however, is the art work he did for the Gloucester Memorial, which was unveiled recently.

Although he has been back in " civvies " for such a short while, he has already been offered a job as an artist on TV advertising films. A student at Canterbury College of Art for two years, Arnold has gained the National Diploma in Design.

Oscar-winning filmmaker designer and Arnold Schwartzman - who needs introduction no to members of our Society was recently invited to Seoul, South Korea to screen his very first documentary, The Morning Calm that he made during his military service in Korea 60 years ago.

The Korean TV made a documentary about Arnold in 2013

when the director had asked Arnold if he had to design another UN memorial today, what would he do? Arnold tells how he drew some quick sketches for the camera and, to Arnold's great surprise, when the memorial sponsors finally saw his sketches they decided they wished to construct it! Arnold's imaginative design can be seen in the accompanying photographs. The memorial was unveiled in December 2013 (see also the article article on page 8 of our Society's Newsletter 374 for further information).

On his recent return from Korea to his home in Hollywood, California, Arnold sent me some bits and pieces which he thought would be of interest to our members. Amongst those bits and pieces was the following paragraph from the Editorial which appeared in the December 1957 issue

of the Royal Army Chaplains' Department Journal describing the four plaques which Arnold had designed that year for the "Gloster Memorial" in Korea:

By July, Korea is in the midst of a season of heavy and almost continuous rain. It was impossible to have the ceremony any later than June 29th, but it proved impossible to get the slabs from Hong Kong by that date. An artist, Pte Schwartzman, of The Royal Sussex Regt, painted plywood as imitation slabs as temporary makeshifts to enable the ceremony to take place. So cleverly was the work executed, with due regard to the angle of the sun and the positioning of shadows, that many people had to be convinced that they were imitations. The real slabs were in position before the evacuation of Commonwealth troops in mid-July. They left behind a lasting memorial to their comrades who were amongst the most gallant of those who fought for the freedom of Korea.

Congratulations Arnold, we are all very proud of you in Margate!

The Willis Organ in the former Royal Sea Bathing Hospital Chapel - An Update

The following e-mail dated 26th September 2016 was sent to Nick Dermott, Heritage Advisor at Thanet District Council was forwarded to the Civic Society for information:

I am pleased to tell you that the award of a Grade l Historic Organ Certificate (HOC) for the Willis organ in the Chapel of the Royal Sea Bathing Hospital was endorsed by the council of the British Institute of Organ Studies (BIOS) at its meeting in London last Saturday (24th September). A grade 1 HOC signifies 'an organ of exceptional interest' and the certificate will include specific information that underpins the award. As you will be aware from recent correspondence with the BIOS chairman, Dr Alan Thurlow, the stage is now set for consideration of the organ being listed in the newlyestablished 'Organs at Risk Register'. I hope that this information will assist in the safeguarding, and ultimately restoration, of this very interesting organ in what I hope will be the rejuvenated chapel in whatever form it takes. Five new Conservation Areas declared for Cliftonville

It was exactly three years ago that Thanet District Council announced that they were holding a meeting to discuss the then-current position regarding the designation of six new Conservation Areas in Cliftonville West (see MCS Newsletter 373, page 10).

Then, in January last year, TDC declared the Ethelbert Road/Athelstan Road to be a Conservation Area (CA) as it was considered to be an area of special architectural or historic interest and that it was felt desirable to preserve or enhance its character or appearance.

At the end of November 2016, TDC announced that it had designated the remaining five areas in Cliftonville West previously identified for consideration as Conservation Areas - to be Conservation Areas. The five new designated CAs in Cliftonville are:

Northdown Road CA

Norfolk Road/Warwick Road/Surrey Road CA

Edgar Road and Sweyn Road CA

Clifftop CA

Clifton Place/Grotto Gardens CA

Copies of the plans for each of the above areas showing the boundary of the Conservation Area are available for public inspection at Thanet's Gateway Plus, Cecil Street, Margate which is open Monday to Friday 9.00am to 6.00pm (late night until 8.00pm on Thursday) and Saturday 9.00am to 5.00pm.

One of the principal effects of these designations of these areas as Conservation Areas is that planning permission must first be obtained from TDC for the demolition of all unlisted buildings within each of the Conservation Areas.

This glass souvenir paperweight featuring a view of the former Iron Bridge, in what was known at the time as Lower Marine Terrace, Margate, is believed to date from around the mid-1870s. In the foreground, the two ladies in their fine dresses and the dapper gentleman with his cane walking-stick are standing on what was known as Hazardous Row. The image shows a number of bathing-machines on the sands and the houses in Marine Terrace (what then were private houses sometimes taking in lodgers). Marine Drive was yet to be built as was, of course, the Clock Tower. Note the level of the sands relative to the promenade. Since that time, the level of the sands has risen. This view today would be overshadowed by both Dreamland Cinema and Arlington House.

Glass paperweights were an extremely popular souvenir of visits made to the seaside in the 1870s/1880s but they are notoriously difficult to photograph without distortion due to reflections - as can be seen in this photograph. □



Pulhamite at Newgate Gate now dated to 1901

The Pulhamite artificial rockery at Newgate Gap featured in Newsletter 368 page 10. An estimate had been made as to the date of its construction as 1895-1900 as it was quite apparent from the Edwardian postcard on the right that the rockery was newly built when the photograph was taken. Now, thanks to local artist Newton Whitelaw, we know that the rockery was built in 1901 for she located a date inscribed high up in the rockery.

The date 1901 is six years before the Newgate Gap Bridge was erected in 1907 to commemorate the 50th anniversary of Margate being granted a Charter of Incorporation in 1857 when Margate first became a Borough. Today, of course, it is that very same Charter of Incorporation which the Margate Charter Trustees are trustees of - hence their name.



It would have been Margate Borough Council who chose to commission the firm of James Pulham & Son to construct the rockery but it would appear that there was no direct connection between the building of the rockery in 1901 and the building of the Newgate Gap Bridge in 1907. □ JB

Book Reviews

Chris Sandwell brought my attention to these two super publications when together we were examining the c.1900 panoramic photograph of Dane Valley (see article on page 8 of

this issue of the Newsletter). The maps are 2010 reprints of original 1896 Ordnance Survey 1:2,500 maps, reduced to a scale of about 14 inches to the mile. They are, however, really good and of a manageable size. They also contain a very good history of the town on the backs of each of the two maps. The maps also show the location of Ordnance Survey benchmarks in the town at that time! I obtained my copies of the maps from Amazon at a little over £5 each (including p&p). Be aware though that the Margate (North) map comprises approximately 60% sea and only 40% land! The Margate (South) map, however, is almost wholly land. ARTS AND CRAFTS EXHIBITION AT WESTGATE

An interesting exhibition was opened at the Châlet, Westgate-on-Sea, on Monday afternoon and for a first venture of the kind the collection was an excellent one. The arrangements, ably carried out under the supervision of Miss Claire Wain, were in every way as perfect as they could be, and the number of exhibits was large, many of the articles in the collection being of considerable value and of special interest. Among the exhibits were some fine examples of rare old lace, exquisite glass and china, and many other things which proved an irresistible attraction. Paintings, water colours and photographs made a much-admired show, conspicuous among which was the canvas painted by Mr Harold Waite, which secured the first prize of some 25 offered. Miss F. Wain Miss C. Wain and Miss Hastings were also exhibitors in this class and taking prizes.

Mr F. Morgan's picture "Out of Touch" was judged the best in the show. The sections devoted to needlework, cooking and crafts were greatly appreciated, and one striking exhibit in the latter was a fretwork Noah's Ark, the work in which had been cleverly executed. Sir William Ingram offered a prize for the best design suitable for a coat of arms for Westgate and this was won by Mère Ste Pierre of the Ursuline Convent, and, it is understood, the design has been approved by the Parochial Council and Parish Council. The design includes a portrait of St Mildred, a deer, the Kentish horse and a galley. It has Dent-de-Lion Castle as a crest and bears a motto which, translated, means "Driven by the wind to Westgate and there it will remain." Miss Cazalet took the second prize in this competition.

She was born in 1893. The medal now in private hands - was brought along to a meeting at the Westgate Heritage Centre in 2013 by Gail & Ron Sheldrake who very kindly lent it to be photographed for the Heritage Centre Archives. □

This architect's provisional drawing of the Town Hall, St Mildred's Road,Westgateon-Sea shows the building as originally planned with a 'shingle steeple', with a clock flush to the building and without the bronze figure of an angel blowing a trumpet which is mounted on the front of the building. The architectural style of this Grade II listed building is generally referred to a 'Swiss Gothic'.
