The Turner Contemporary gallery beside Droit House

Much excitement is building up in our town as the opening date of the long-awaited Turner Contemporary gallery fast approaches. Saturday, 16th April is the date when it opens and we await with anticipation the many events that are being laid on to mark this important occasion. More significantly, we look forward to the long-term impact that the gallery will have on our town. As we all know, much public money has been invested in this project at a time when huge spending cuts are having to be made across the country. Kent County Council, in particular, has funded the major part of this investment and their belief in the success of this project to assist the re-generation of our town deserves due recognition and support by local residents. Together, we should each contribute towards the success of the project by encouraging friends and family to visit the gallery and promote its various exhibitions. By doing so, there will be a greater chance of the gallery becoming a much heralded attraction in the town drawing art-lovers from far afield. Margate Civic Society has played an important part in this project and members are reminded that it was John Crofts who first promoted the idea of a Turner gallery when he was Chairman of the Society back in 1995. Since then, the Society has consistently supported the concept of a purpose-built art gallery in the town recognising the important connection the town has with Joseph Mallord William Turner - the greatest British artist of all time! The architect for Turner Contemporary, Sir David Chipperfield, was recently awarded the Royal Gold Medal, for his lifetime's work for architecture, by the Royal Institute of British Architects. This award is one of the the world's oldest and most prestigious architecture prizes and follows the award of the RIBA Stirling Prize to David Chipperfield Associates in 2008. Will his design of the Turner Contemporary earn him yet another award? We will just have to wait and see. But let's hope that it does

As many of our members know, another of our members - who is also a regular contributor to our Newsletters - is Arnold Schwartzman. Arnold has lived in Hollywood since 1978 but, as a boy, lived in Cliftonville and attended Holy Trinity Primary School and King Ethelbert School before going on to the Thanet School of Arts and Crafts. Arnold maintains his interest in Margate and often makes visits to the town when he is back in our country. Indeed, he last visited Margate in October when he was given a private tour of the Turner Contemporary gallery by its Director, Victoria Pomery, shortly before the construction works at the gallery were completed.

Arnold was recently the Special Guest at a leading event organised by the Washington Next Generation Board that was recently held at the Holocaust Museum in Washington DC, USA, entitled: 'The Power of Film and the Holocaust: an evening with Sir Ben Kingsley'. The event took place on 1st March 2011.

Arnold was delighted to be asked by his friend Sir Ben Kingsley to offer a special introduction to the programme as Arnold's 1981 film, *Genocide*, was the first film on the subject of the Holocaust to be honoured at the Academy Awards.



India House - one of Margate's finest old houses



India House, Hawley Street (The Limes is shown on the right-hand side)

India House, an attractive brown- and red-brick house, is situated in Hawley Street, on the corner of New Street. It is Listed Grade II* as a building of "special historic interest" and an early example of "an eccentric seaside villa". Pevsner refers to it as "the best house in Margate". It was built in about 1770 by a Captain John Gould (1722-84), a wealthy man, who had spent much of his life as a tea-planter in India. Several high-up employees of the East India Company, such as John White Masters and William Smith, later retired to Kent, in particular to Faversham, but Captain Gould had no connection with the Company. He built himself a house in Calcutta, of which India House is reputedly a replica. This, however, has never been

substantiated and the house has never been located.

By 1776, Margate had become a popular place for the rich to come as visitors and also as residents. Seaside air was becoming fashionable – the original Sea Bathing Hospital dated from about 1792, predating the existing classical building of 1820. Cecil Square had recently been built (1769) and Hawley Square was soon to follow.

In 1759, John Gould was appointed a Commissioner for Restitution after the Siege of Calcutta. He was also an Alderman. He returned to England in 1766, eventually settling in Margate. This could well be the first recorded example of someone retiring to the seaside. His Portuguese-

Indian wife, however, reputedly remained at their Calcutta house. He died in 1784 and is buried in St Leonard's

Church, Upper Deal. India House was inherited by his son, John, the result of Gould's liaison with his Margate housekeeper.

After his death the house was used as offices by the East India Company. In the 19th century, it was occupied in turn by Mr Chippendale - a banker, Mrs French (1841) and Mr Walter Green (1881) - a wine merchant. In 1897, it

became the home of

Phyllis Broughton, the famous "Gaiety Girl". In 1922, at the age of almost 70, she married a Margate doctor, Dr Thomson, of the same age. He sadly died after only

two years of marriage. In 1905, Dr Harnett, Resident Surgeon at the Royal Sea Bathing Hospital, died here. In 1917, it was occupied by Dr W. C. Esse, ex-Chief Physician at the Royal Hospital, Chelsea.

The legal firm of Boys & Maughan had its roots in 1803, when John Boys set up a practice. He was joined in 1837 by John Harvey Boys. The latter's son, Toke Harvey Boys, joined the firm, but later set up on his own. In 1902, he joined up with C. E. Maughan to form the firm of Boys & Maughan. Toke Harvey Boys died in 1916 and is interred in St John's Church, Margate, where there is an alabaster plaque in his memory. His signature may be seen on the back of a map of East Kent on the staircase in India House. In 1920, Boys & Maughan moved into India House, where they remain to this day.

The house is largely constructed of brown brick, in Flemish bonding. There is some additional red-brick dressing. The roof is made of clay tiles. The front of the house is approached by an elegant set of double stone "perron" steps leading up to the main entrance. Above is a crenellated parapet. Below the steps is a door leading into a basement. Neither this door nor the upper main door are in use today. Above the main doorway is a small oval, œil-de-bœuf ("bull's-eye") window. Inside, the house is unusual in having only one storey at the front, but two at the rear. The hallway has an archway dividing the front from the rear. There is attractive panelling, a small but elegant staircase and several beautiful Adam-style fireplaces.

The house is now linked internally to The Limes, next door – an attractive early 19th century building, which

until around seven years ago housed a medical practice. Today, it is used as the main entrance, through which access is gained to India House. At the back some one-storev extensions were added in more recent times. The New

Street side of the house bears a blue plaque, erected by Thanet District Council. In front of the building is a Town Pride Award, given to Boys & Maughan in 1989 for the lamp-post and hanging sign outside the

house.

Margate War Memorial WWI Roll of Honour

Amongst the names on Margate War Memorial is that of A. W. Maughan. The following particulars are extracted from the Roll of Honour to be found on Margate Civic Society's website

MAUGHAN A. W.

2/Lt Alfred William Maughan, 285th Siege Battery, Royal Garrison Artillery

Killed in action on 24th June 1917, aged 37. He

was born at Mickley, Northumberland and was educated at Durham School and at University College, Oxford, graduating in 1903. He was a schoolmaster at Hove, Sussex when he enlisted in November 1915 and joined the 28th Bn Royal Fusiliers. In November 1916, he was commissioned into the RFA. His widowed mother lived at Northdown Avenue, Cliftonville. He was unmarried. His brother, Cyril Collingwood Maughan, was a partner in Boys & Maughan, a firm of solicitors still practising today in Margate.

Correspondence

Members Janet & John Robinson recently tipped off your Editor about a new website created by Anthony Lee who has recently joined the Society. I immediately visited the website and was most impressed with what I found. I made contact with Anthony Lee and received the following letter which provides valuable information about the development of the website which will be of particular interest to members who are online:

Dear Mr Brazier

New Margate History Website www.margatelocalhistory.co.uk

Many thanks for the e-mail message about my website. I am pleased that you like the site and I would be delighted if you publicised it in the Newsletter. That would be an excellent way to let people know that the site existed. You asked about how I hope to develop the site. Apart from adding a few more maps, the main idea over the next months is to start adding pictures to the site (prints. photographs, stereoviews and postcards). The idea is that clicking on a particular location on the maps will open up a set of pictures of that location. Two of the maps (Edmunds Map and the 10 ft/mile OS Map) have dropdown menus from which you can go straight to a street or location of interest. These locations are marked by coloured spots, and the idea is that clicking on these spots will open a set of views of that location. As an example, if you click on the St John's Church button on either map, a Gallery Viewer will open showing views of the Church - hover above the menu buttons at the bottom of the Gallery Viewer to see a variety of options for controlling the Viewer.

Initially, I will use illustrations from my own collection, but, of course, that will be quite limiting, and I would very much like to add pictures from other people's collections, if that were possible (suitable acknowledgements could be included on the web pages). Also, I know that there is lots of important material in the old Margate Museum - a coloured version of the Edmunds Map and an early large scale Ordnance Survey map for example, together with various rare prints. Perhaps there would be some way to include material of this kind? But that is all for the future. The design of the site is quite flexible, and it would be possible to include much more text on the site than there is at present.



These pictures tell the story to date of Margate's last surviving K6 telephone kiosk which 'adopted' by Margate Charter Trustees a year or so ago and relocated from its former site in Norfolk Road to the Stone Pier (now referred to by many as Margate Harbour Arm). The first of the pictures show the kiosk still in use five years ago shortly before the St George's Hotel was demolished. The second picture shows the kiosk after the hotel had been demolished and after the telephone kiosk had been decommissioned by British Telecom. The third and subsequent pictures show how the kiosk has been progressively vandalised since its removal to the Harbour Arm. The pictures speak for themselves. Note its nearness to the new Turner Contemporary gallery which will open to the public on 16th April 2011.

A tale of three cliff-top public shelters - a photographic record showing how two of them have changed over the last five years

The former Borough of Margate district has seventeen public shelters remaining in situ. Some of them are replacements for earlier Victorian shelters but by far the majority are the original shelters put up to provide shelter for the many visitors that the Borough once attracted each year. Over the years, many of these shelters have suffered from vandalism and their ongoing maintenance is a matter of concern to Thanet District Council. In October 2005, yours truly decided to photograph all of the public shelters on the cliff-tops and the seafront as a record of their condition at that time. It has to be said that in the little-over-five years since that date, many of the shelters have suffered much damage. It seems that the shelters make ideal goalposts to many budding Wayne Rooneys in the area with the result that many panes of glass have been shattered and the frameworks damaged. Note the re-positioning of the metal posts at the Barnes Avenue shelter. In this article, we look at how two of these shelters have changed dramatically in the last five years.





The first shelter - located between St Mildred's Bay and West Bay, Westgate-on-Sea - was designed by Charles Moxon for 20 persons. He was an architect who lived at *Beach Cliff* (now demolished) and was the father-in-law of Sir William Quiller Orchardson RA who lived at *Ivyside* (also demolished), next door to his in-laws. The shelter was built in 1888 by Lockwood & Co. The picture on the left was taken in October 2005 and the one on the right was taken in October 2010.





The second shelter above is approximately one mile due east of the one shown at Westgate and is located near the north end of Barnes Avenue, Westbrook. This shelter is one of a pair (see picture below) which, it is believed, were constructed in the late 1920s/early 1930s complete with electric lighting. The picture on the left was taken in October 2005 and the one on the right was taken in January 2011. Note the adverse visual effect of removing the windows from these shelters.

The picture on the right shows, in the foreground, the shelter on the cliff-top at the north end of Westonville Avenue. This shelter is to the same original design as the cliff-top shelter at the north end of Barnes Avenue which can be seen in the background. Note also the four-wheel drive vehicle parked alongside by a dog-walker. This photograph was taken at the end of January 2011.



Winter Gardens 1911-2011



The above picture is taken from the cover of the programme for concerts by The Municipal Orchestra conducted by Mr Edmund Maney held at Westonville Pavilion (later to be known as Westbrook Pavilion), the Oval Bandstand and at the Margate Pavilion (later to be known as the Winter Gardens) in September 1911. The programme was produced in the form of a Postal Souvenir and was printed by Bobby & Co Ltd. According to a note printed in the programme, the cover design depicts 'the sea side of the New Pavilion at the Fort when completed'. The picture, which bears the signature of Reynolds Sykes, shows the artist's impression of the view from the balcony of what is now simply known as the Winter Gardens. What a glorious Edwardian idyllic image this presents. A paddle-steamer is seen leaving the Jetty on an excursion, rows of bathing-machines are in-shore and there are groups of beach-tents for changing into


beach-wear on the sands. There are bowls of flowers along the length of the balustrade and everyone on the balcony is wearing a hat. One lady is carrying a parasol. Note also the ladies' hats: everyone is a milliners' delight. Who could resist coming to Margate and visiting what was then the new attraction? Of course, the above image may well have been quite different from reality a hundred years ago.

Whilst we still have the Winter Gardens, the view from the above location has changed so much over the last hundred years with now only the promenade, the sands, the sea and the sky remaining. There was talk a few years ago when the Turner Contemporary gallery was given the 'green light' that not only would a new hotel be built on the Rendezvous site, but that money would be found to refurbish the Winter Gardens hopefully in time for its centenary in 2011. Sadly, neither of these aspirations will be achieved by the time of the opening to the public of the Turner Contemporary gallery on 16th April 2011. One wonders what will be the fate of the new gallery in one hundred years' time. But that will be for future generations to find out!

The Pavilion was opened on 3rd August 1911 after just nine month's construction. It is reported that the total cost was some £26,000. The building was used as a receiving station during the Dunkirk evacuation and, later, was extensively damaged by enemy bombing during the Second World War.

To mark the centenary of this fine building, the following views have been selected from Richard Clements' magnificent collection of old Margate postcards. We hope that you will find them interesting in this centenary year.







The latter were demolished in the late 1930s when the new road (Fort Hill) was built as a dual-carriageway. The Victorian public shelter at the top of Fort Hill has since been replaced with a more modern design shelter and most of the buildings in Zion Place have been demolished. The Clifton Baths were still in operation when this photograph was taken and they can just be seen behind The Paragon. Later, the site was to be developed as the Lido. □




In Memory of 'Lord' George Sanger 1825-1911

'Lord' George Sanger, showman and circus proprietor, died an untimely death 100 years ago this year and his funeral took place in Margate on 5th December 1911. It is, therefore, fitting that Birchington Heritage Trust Museum should have these two most interesting prized personal mementoes of 'Lord' George Sanger on display until September.

The cigar-box was presented by Queen Victoria to 'Lord' George Sanger on 17th July 1899 at Windsor Castle. The Queen was a great admirer of 'Lord' George Sanger and his world-renowned circus and had invited him to take his Equestrian and Zoological Exhibition to Windsor Castle for a private show before Queen Victoria and her invited guests. One may presume that the cigar-box was full when it was presented to 'Lord' George Sanger. Note that the inscription on the lid of the cigar-box refers to Mr George Sanger rather than to Lord George Sanger: one can imagine how much Sanger would have preferred to have seen 'Lord' rather than 'Mr'. The assay mark on the silver box shows that it was assayed at London in 1887 - the year of Queen Victoria's Diamond Jubilee. 'Lord' George Sanger's granddaughter used to ride the ponies that were used in his circus and kept them on her husband's farm at Cleve Farm, Acol, over the winter months.

The brass business-card case would have been carried by 'Lord' George Sanger in his pocket. Although - like the cigar-box - it is now empty, it is believed that the design of his business card would be the same as shown on the front of the case. From his appearance, the case would probably date from around 1880. It is hoped that further research will identify the years when Gustavus Foster (if that was, indeed, his real name) was employed by Sanger as his General Manager at Margate.



Founded in 1968, the Margate Civic Society is a registered charity. It is a founder member of Civic Voice and is affiliated to both the Kent Federation of Amenity Societies and the Kent History Federation.
