President's Report 2010/11

Sitting in the garden getting tanned by a hot sun, one tends to forget the horrors of the past winter. It is time again to write the President's report.

At last, the Turner Contemporary is open and the number of visitors has passed all expectations. The Old Town appears to be benefiting from this, the Motor Cycle Convention, the Air Show and other events. Is Margate on the up? I hope so!

It looks as if those who wanted Tesco on the Arlington House site might have their wish: I do hope we will not live to regret allowing this to happen. I still fear traffic congestion will become a daily problem especially when the Dreamland Heritage Park opens in 2013.

Your Committee have become involved with the quest to re-open both the Margate Museum and the Margate Caves.

We agreed to continue our membership of Civic Voice and have had meetings and consultations with various members of the organisation and the Kent Federation of Amenity Societies (KFAS). The amount of paperwork that arrives via the web from Civic Voice is staggering and sometimes too much for this 'oldie' to take in! We have been asked to host the KFAS Autumn Conference to be held at the Turner Contemporary on 12th November 2011.

We also meet up with both the Ramsgate Society and the Broadstairs Society but so far have had no success with Thanet District Council for the reinstatement of the Property Services Consultation Forum despite promises from both the Leader of TDC, Bob Bayford, and also the last Council officer responsible, that it would be started up again. I am tired of 'banging my head against a brick wall' and, now that I am no longer Chairman of the Forum, I have handed over to Jack Tullett, President of the Broadstairs Society, who continues the battle.

I still book our speakers and trust that you will enjoy those selected for the new season including John Robinson, a member of our Society, who was booked to give us a talk last December but the meeting had to be cancelled at the last minute due to the very bad weather conditions that day. I have been booking speakers now for over ten years and I feel that it is time that I handed this task over to someone else. Are there any volunteers? I am not going to last for ever and the sooner someone takes on this task the better while I am still around to help.

Now it is time for my round of thanks:

Pamela Pople - our Chairman - has worked tirelessly for the benefit of the Society attending many meetings and organising the Town Pride Awards with James Brazier and Mike Wilton. On behalf of our Society, Pamela was given a donation of £70 from Tony Leggatt for writing an appraisal on one of Coastal Developments Ltd's housing projects in Herne Bay - another welcome addition to the Society's funds. I must also thank Pamela for obtaining a suitable venue for our Civic Day event held on 25th June. Most of the Committee turned out on that day to help and some new members

were enrolled. Harry Scobie - turns out for meetings and events whenever his busy schedule allows and is a very useful Vice-Chairman. James Brazier - his Newsletters get better and better, and he is taking on more tasks. A very useful and talented Committee member. On behalf of the Society, James attended a Civic Day Workshop at Ashford earlier in the year. His subsequent work on the our Civic Day event was very much appreciated by all who visited our display. James also stepped in to take

a party from the Ramsgate 41 Club on a tour of Old Margate during the evening of 15th August. The person who was to have led the party was unavailable at the last minute and James had just six hours in which to prepare for the task before him. The tour proved to be a success and the 41 Club very kindly made a donation of £25 to Margate Civic Society as a gesture of thanks for James's services that evening.

Mike Wilton - has done wonders with our website. He is also our Treasurer and very efficient and willing to help out wherever possible. On 5th November 2010 - the 88th anniversary of the unveiling of Margate War Memorial - Mike put James's research of all the persons whose names are inscribed on Margate's civic war memorials on our website. The fruits of James's research are now available to anyone with internet access.

Lynda Smith - has cleaned up the Membership list, saving the Society a considerable sum in postage costs. Lynda has also chased those who have avoided paying their membership fees, and stopped postage of Newsletters to those who are no longer with us. Lynda, also, was one of the judges for the 2011 Town Pride Awards.

Steve Villette - a mine of useful information and brings the loud-speaker gear etc. to our meetings and the display boards when needed.

Julian Smith - is a willing helper and was another of the judges for the 2011 Town Pride Awards.

Drapers Windmill Trust was founded in 1965 and saved the mill from demolition. Funds were raised to restore the mill in the 1970s and Kent County Council purchased the building. After 45 years, the Trust continues as a small registered charity dedicated to opening the windmill to the public and also doing some maintenance and restoration works.

All major projects are looked after by Kent County Council. The mill is open on Sunday afternoons in June, July and August.

In the last issue of the Newsletter, we featured this medal which 'Lord' George Sanger, as President of the Margate Beaconsfield Working



Men's Association, had presented to each member of the Executive Committee of that body in 1882. In this issue, we feature some more mementoes of that Association which form part of Margate's history: two postcards and a war memorial.



Members of the Beaconsfield Conservative Working Men's Institute (known as Beaconsfield Club) moments before setting off on their outing in June 1913. The Club's premises at 10 Cecil Square can be seen behind the brake (note the word 'INSTITUTE' on the window bottom right) at the rear. It is most probable that a number of the younger seen men on this postcard are amongst those whose names appear on the Beaconsfield Conservative Working Men's Club War Memorial (see opposite page)

The postcard below shows the bunting-strewn Isle of Thanet Conservative Registration Offices in Elephant Hill (now Marine Gardens) and the postcard is believed to date from around 1920. Judging by the clothing worn, the photograph was taken during the summer months. Note also the roof of a motor-vehicle which can be seen going up Elephant Hill. Perhaps the occasion was a carnival or, possibly, local peace celebrations held in 1919 to mark the end of the Great War 1914-18. Records show that the Beaconsfield Club occupied part of these premises at around that time



The Beaconsfield Conservative Working Men's Institute Ltd - as it subsequently became known - later moved to premises in Hawley Square. It is understood that the club no longer exists. The Club was named after Lord Beaconsfield - formerly Benjamin Disraeli who was born on 21st December 1805 and died on 19th April 1881. He served as Conservative Prime Minister in 1868 and again from 1874 to 1880. □

The Beaconsfield Conservative Working Men's Institute War Memorial 1914-1918



The information on each of the men named on this war memorial, as shown below, is extracted from the Margate War Memorial webpage on Margate Civic Society's website. The differences in the spelling etc of some of the names should be noted. Their names, as they appear on Margate War Memorial, are shown in **bold** below.

AUSTEN H.G.

2529 Sgt Horace George Austen, 7th Bn The Buffs

Killed in action on 28th November 1916, aged 22. He was born at Margate. *Interred at Stump Road Cemetery, Grandcourt, Somme, France*

BAGGOT [sic]A. T. J.

S/15390 Sgt Alfred Thomas James Baggott, Royal Army Service Corps

Died when he was burnt while asleep at Hangest-sur-Somme on 11th February 1919, aged 37. He was born at Shropshire and lived at Zion Place, Margate. He left behind a widow, Eliza. *Interred at Crouy British Cemetery, Crouy-sur-Somme, France*

CURTIS R. C. [sic]

Believed to be 1466 Trooper Frederick Rupert Curtis, Household Bn, Household Cavalry

Killed in action on 11th May 1917 aged 31. He was born at London and lived at Margate. Although his initials are different from those shown on both Margate War Memorial and Margate War Shrine, there is a reference in a contemporary local newspaper to a Trooper Charles Curtis who, it is believed, is the same soldier as shown above. *Commemorated by the CWGC on the Arras Memorial, France*

PARAMOR H.S.

550710 Rifleman Harry Spencer Paramor, 2/16th Bn London Regiment (Queen's Westminster Rifles)

Died in France on 7th November 1918, aged 30. He had enlisted in September 1914 and served in Egypt and France. He was a family member of the Margate builders Paramor and Sons who built the fine Margate War Shrine. *Interred at Terlincthun British Cemetery, Wimille, Pas de Calais, France*

PHILLPOTT [sic] F. H.

Z.4283 Able Seaman Frederick Philpott, Nelson Bn, Royal Naval Division

Killed in action on 22nd January 1917, aged 26. He was working as a Newsagent when he joined the Royal Naval Division in November 1915 at the age of 25. His home was at Poet's Corner, Margate. *Commemorated by the CWGC on the Thiépval Memorial, France*

SUMMERFIELD H.T.

M2/032089 Pte Henry Thomas Summerfield, 70th Auxiliary Petrol Coy, Army Service Corps

Killed by a bomb dropped from an enemy aircraft on 6th December 1917, aged 39. He was born at St Pancras, London and lived at Bailey's Cottages, Zion Place, Margate. He left behind a widow and five young children. Prior to enlisting, he was a motor-driver in the employ of Mr J. W. Sayer.

Interred at Brandhæk New Military Cemetery No. 3, Belgium

Margate's Wartime Rolls of Honour

Members will be aware that Rolls of Honour recording the names and personal information on those who lost their lives whilst serving their country during the twentieth century were launched on the Society's website last November. Since then, the Rolls of Honour - covering Margate, Westgate-on-Sea and Birchington - have attracted interest from around the world thanks to the internet. Additional information has been provided and a number of enquiries have been received from family members which has been most gratifying. Also, in a couple of instances, family members have supplied photographs of their loved ones whose names are inscribed on these war memorials. It is hoped that publication of the following examples will prompt others to submit additional information and photographs.

Shortly after the launch of the Rolls of Honour on our website, I received a telephone call from a David Impett who told me that he was the son of Henry Charles Impett whose name is inscribed on Margate War Memorial and that he was now living in Harrow, aged 76. His attention to the Roll of Honour had been drawn by a friend of his who had access to the web and had found Henry Impett's details on our website. Until I received that phone call, I was not aware that Henry Impett's son was named David and that David was now was living at Harrow.

The entry on the Margate WWII Roll of Honour on the Society's website now reads as follows:

IMPETT H. C.

1572803 Gunner Henry Charles Impett, 48 Bty, AA Regt, RA

Died in a prisoner-of-war camp in Borneo on 21st July 1945. He was aged 33. He had volunteered for the Army in May 1940 and went to the Far East 18 months later. After being in Java for only three weeks, he was posted as missing. It was not until a year later that news was received that he was being held as a PoW. He left behind a widow, Violet, and a nine-year-old son, David. *Interred at Taiping War Cemetery, Malaysia*

The following e-mail was received from Rebecca Eaton who lives in Canada:

Hello

I wanted to thank you very much for maintaining the Margate Roll of Honour. I have been trying to determine for sometime if my great-grandfather, Frederick Thurling, who was killed in France in WWI, was memorialised anywhere in England. He moved around a bit, so I wasn't sure where, until I found the information on your website thank you again!

I do appreciate the memorial, and the fact that not only have you listed the name, but there is even some background information on the men who died - just a little something to humanise these great heroes, and remind us they were sons, fathers, and husbands. Thank you, Rebecca Eaton The entry on the Margate WWI Roll of Honour on the Society's website reads as follows:

THURLING F.

46282 Battery Sergeant Major Frederick Thurling, 70th Battery, 34th Bde, Royal Field Artillery

Killed in action on 4th August 1916, aged 27. He was born at Maidstone and enlisted at Margate. He served with HM Forces for nine years. His parents lived at Ethelbert Road, Cliftonville.

Interred at Dantzig Alley British Cemetery, Mametz, Somme, France

In an exchange of e-mails, Rebecca Eaton told that her grandmother is the daughter of Frederick Thurling and that her grandmother was only two-and-a-half years old when her father lost his life. Rebecca's grandmother is now 97 years of age and living in Leicestershire. The photograph below of Frederick Thurling is the only one that Rebecca's grandmother has of her father and has kindly given permission for it to be published in the Newsletter.

The entry for Frederick Thurling on the Society's website will shortly be updated to include some of the additional information that Rebecca has kindly supplied.



A studio photograph of Frederick Murray Thurling kindly supplied by his greatgranddaughter Rebecca Eaton. Frederick Thurling was 27 years old when he was killed in action during the Battle of Delville Wood. He left a widow, Teresa (née Lloyd), and a daughter, Jessie.(now aged 97 and living in Leicestershire). His parents were Nicholas and Phoebe Thurling

The following e-mail was received from Jeremy O'Keefe:

Dear Sirs

I thought your members might be interested to see a photograph of Sgt Dennis Vivien Chant, RAF, former Margate resident and killed on the night of 14th October 1941 in an Avro Manchester bomber returning from an attack on Cologne. His name is inscribed on the Margate War Memorial.

Dennis was my father's second-cousin, Dennis's mother, Hilda Chant (nee Addis), was one of my grandmother's younger sisters.

My grandmother was a Margate resident and worked as a seamstress for Geo.A Heath on the corner of High Street and New Street, now site of Roy House. Yours

1250594 Sgt Pilot Dennis Vivien Chant, 207 Sqdn RAFVR

Killed in action during a bombing raid on 14th October 1941. He was aged 21. He was educated at Margate Central School and had recently married.

Interred at Shaffen Communal Cemetery, Diest, Belgium

Some of Turner's Hand-Tinted Margate Prints



An engraving by George Cooke of one of J. M. W. Turner's many paintings of Margate, This engraving, published in 1824, shows salvage of a shipwreck in the foreground and Hooper's horizontal mill on the horizon. The White Hart Hotel on Marine Parade and houses in Albert Terrace can also be clearly seen. Holy Trinity Church was built four years after this engraving was first published



This engraving by R. Wallis was first published in 1832 clearly shows Holy Trinity Church on the horizon



This engraving by Thos. Lupton was first published in 1856 and was featured in our Autumn Newsletter (No. 360). Again, Holy Trinity Church can be clearly seen on the horizon The three Turner prints shown on this page are identical to the three Turner prints listed in the former Margate Corporation *Catalogue of Prints, Drawings and Maps of Old Margate* that was printed in 1930, as follows:

Margate Museum re-opens on a regular basis

The last in the current BBC1 series of *Who Do You Think You Are?* will feature Tracey Emin and it is understood that the programme will be broadcast on Wednesday, 12th October at 8.00pm. This popular TV series in which a well-known personality's family background is delved into by family-history experts is one of the BBC's most successful programmes. There can be little doubt that Margate will feature prominently in the programme on Tracey Emin's family background and that Tracey Emin will speak fondly of her time spent in our town. 'Mad Tracey from Margate' - as she is often known - is an ambassador for the town and always speaks highly of its architecture and, particularly, its amazing skies. Dreamland's Scenic Railway's listing upgraded from Grade II to Grade II*

English Heritage has recently upgraded the listing of Margate's Scenic Railway from Grade II to Grade II* despite a large proportion of it being destroyed by fire some three years ago. The Dreamland Trust is currently restoring the Scenic Railway which it hopes will form the main attraction of the Dreamland Heritage Park when it opens, possibly, in 2013. The upgrading of the Scenic Railway's listing status by English Heritage follows an application made by Thanet District Council. Perhaps an unintended consequence of TDC's application has been the need to refer the plans for the proposed Tesco superstore on the Arlington House site back to the Planning Committee for further consideration. \Box

New Award for Sir David Chipperfield

Turner Contemporary architect Sir David Chipperfield has recently received an award from the Critics' Circle for his Turner Contemporary gallery at Margate and the Hepworth Gallery at Wakefield, Yorkshire. This award is additional to the Stirling Prize that he was awarded in 2008 and the Royal Gold Medal which he was awarded earlier this year by the Royal Institute of British Architects. These awards can only result in a greater appreciation of his work as a leading British architect and to recognition of his buildings as works of visual art in themselves. \Box

New Exhibition at Turner Contemporary

A new exhibition at Turner Contemporary is due to open on 17th September 2011. Its title is *Nothing in the World but Youth* and is a collection of 200 works by 94 artists. Amongst the exhibits that will on display are fifteen early works by Turner including several watercolours of Margate painted in the 1780s. The exhibition will run until 8th January 2012. The life-size marble sculpture *The Kiss* by Rodin will also be on display in the Sunley Gallery from 4th October until 2nd September 2012. Be sure that you don't miss these. \Box

The opening of Turner Contemporary on Saturday, 16th April 2011 - and how computer software contributes to our Newsletter



The above panoramic photograph was taken on the day that Turner Contemporary opened its doors to the public -Saturday, 16th April 2011. It shows large number of visitors enjoying the walk along Margate's Stone Pier (sometimes known nowadays as the Harbour Arm) whilst the harbour has only one yacht and two small motor-boats in it. The weather on that day was glorious and no doubt encouraged many to enjoy the occasion. This scene would have been so different a hundred years ago. The harbour would have been full of fishing-boats, colliers, and boats of all sizes. The architecture would also have been quite different. Today, we have the sparkling Turner Contemporary at one end and Arlington House at the other. It can be seen from this picture how Arlington House completely overshadows Dreamland Cinema which, when it was built in 1934/35, dominated Margate's seafront. How things change!

For the technically minded, the above panoramic picture was created by taking five separate photographs using a digital camera and 'stitching' those five pictures together using Serif PanoramaPlus software. Although there is some loss of sharpness in the resultant picture, it is felt that the overall impact of such a panoramic view outweighs any loss of definition. My brother, Rob, took twelve photographs of his large garden by positioning himself in the middle of his garden and rotating clockwise ensuring that each time there was a sufficient overlap for the computer software to recognise common features. By 'stitching' all twelve photographs together, the 360° resultant panoramic view was quite dramatic.

Whilst on the subject of computer software, I am often asked what desktop-publishing package is used for producing the Society's Newsletter. For the last two years, I have used Serif PagePlus which I have found very easy to use. Before that, I managed - with some difficulty, it has to be said, over four years - to produce the Newsletter using Microsoft Word. The transition from a word-processing package to a desktop-publishing package was one that I have never regretted. I also use Serif PhotoPlus software to edit photographs within my Serif PagePlus desktop-publishing software. Finally, I would just mention that none of these packages has been paid for by the Society - and neither am I looking to the Society to meet the cost of them. They are simply part of my contribution towards the undoubted success of our Society. \Box

Book Reviews



The Enigma of the Margate Shell Grotto: An examination of the theories on its origins by Patricia Jane Marsh. This 36-page softback in A5 format is published by Martyrs Field Publications at £4.99 - ISBN 978-0-9569437-0-5

This is a most welcome addition to the bookshelf of anyone interested in

Margate's rich history. The author is a Master of Arts and was the former Director of Studies and Heritage Activities for The English Cultural Experience Ltd. The booklet is extremely well illustrated with many of the pictures in colour. As its title states, the booklet is an examination of the many theories as to the Shell Grotto's origins. The author does not come down in favour of any one theory nor does she outwardly seek to favour any of the many theories that have abounded for over 170 years as to the Grotto's origins - be they Phoenician, Roman, Knights Templar or of more recent origins. Perhaps one day the mystery of the origins of the Shell Grotto will be unearthed. Until then, the Shell Grotto will - in the reviewer's opinion - deservedly retain its Grade I listed status as being a building of major architectural and historical importance. Indeed, the Shell Grotto is Margate's only Grade I listed building - the only other Grade I building in the Thanet towns is Pugin's The Grange at Ramsgate. Copies of this very nicely produced booklet are available from the Shell Grotto and from Michael's Bookshop at Ramsgate. This book is highly recommended and should promote even greater interest in one of Margate's most significant attractions. If you still haven't visited the Shell Grotto, you should do so and get yourself a copy of this book. If you have already visited the Shell Grotto, you should still get yourself a copy of this booklet. Either way, you will not be disappointed.

Postcript

The origins of the Shell Grotto

One of Margate's well-respected local historians was Mick Twyman who sadly died last year. Although he had published some of his research into the origins of the Shell Grotto in *Bygone Margate* (the journal of the Margate Historical Society) a few years ago, he had hoped to have his findings published as a book. I remember him proudly telling me about three years ago that his book was to be published 'before Christmas' but, sadly, it never appeared. Perhaps, one day... - Ed

But the range of subjects covered in each issue of this magazine is such that there will, undoubtedly, always be a number of articles that will interest anyone who wishes to learn more about the history of Kent and its many fascinating places and personalities.

Bygone Kent is our county's only full-colour local history magazine. More Pictures from the Past

Founded in 1968, the Margate Civic Society is a registered charity. It is a founder member of Civic Voice and is affiliated to both the Kent Federation of Amenity Societies and the Kent History Federation.

The Society's purpose and aims are to encourage high standards of architecture and town planning in Margate and its environs (Birchington, Westgate-on-Sea, Cliftonville, Westbrook, Garlinge, Acol, Sarre and St Nicholas-at-Wade); to stimulate public interest and care for the history and character of the area; and to encourage the preservation, development and improvement of features of general amenity and historical interest. To this end, Town Pride awards are given annually to those buildings which have been refurbished, cleaned or modified and which, in the opinion of the Society, have enhanced the appearance of the town. New high-quality buildings are also eligible for the award. The Society also vets planning applications and makes known to Thanet District Council any objections to those applications which it considers necessary.

Evening meetings are held monthly between October and May at the Walpole Bay Hotel, Fifth Avenue, Cliftonville. The lectures, mostly illustrated with slides, are interesting and of local interest; they are also varied in their appeal. A few afternoon meetings are sometimes also held. A Newsletter is published four times a year.
